Biographical Information Overview of Interview: Kathleen Kelly was born March 21st, 1944 in Lake Forest, Illinois. Kathleen graduated from Quincy University in 1966, majoring in medical technology. She met her husband Dennis while in college. Kathleen continued her education at Sangamon State University (SSU) (now University of Illinois at Springfield) while working part-time in various positions: physician office assistant, medical insurance clerk, and lab technician. She completed her M.S. degree in health administration in 1979. That same year, Kathleen began work for UIS as their Continuing Education Coordinator. While working at UIS, Kathleen entered a Ph.D. program in higher education administration at Illinois State University. Her academic interests were issues faced by nontraditional students: access, affordability, and barriers to degree completion. In order to gather data for her dissertation, Kathleen contacted the Illinois Board of Higher Education (IBHE). There she met Dick Wagner (Exec Dir) and Bob Wallhaus (Dir, Academic Affairs). Impressed by her work, they offered her a job. She completed her Ph.D. in 1985. Kathleen began as an intern at the IBHE in 1984, and was promoted over time to Assistant Director, Associate Director and Deputy Director of Academic Affairs, retiring from the IBHE in 1999. Afterwards, Kathleen conducted consulting projects in higher education for other states. Kathleen researched the early history of higher education in Sangamon County after retiring from consulting.
