Abstract

Biographical Information/Overview of Interview: Raymond 'Ray' Stroh was born on August 13th, 1942 in Bloomington, Illinois, and grew up in nearby Sibley, Illinois, where his father worked at a pipeline pump station for Shell Oil. In 1966 Ray graduated from Southern Illinois University in Carbondale, married Peggy Whitacre, and obtained a job with the Department of Mental Health in Springfield. Specifically, he was a position classifier. Ray moved up quickly in the personnel management field, serving as personnel manager at McFarland Mental Health Center, then in September 1968 to Manteno State Hospital, the largest mental health facility in the state. By that time, Ray was working in personnel management, directly reporting to the Illinois Department of Personnel. The Illinois State Personnel Code, enacted in 1955, governed most personnel hiring, discipline, firing, etc. for those working as personnel managers.

In November 1969 Ray was appointed as the personnel manager for the Department of Law Enforcement, and from July 1975 to 1981 as personnel manager at the Department of Revenue. With the creation of the Department of Central Management Services, Ray spent the rest of his state career working there as a Senior Public Service Administrator. He started by overseeing personnel transactions and position classifications for twenty state agencies, but over time his scope of responsibility grew to encompass all agencies, boards and commissions under the governor. During the course of Ray's discussion of his career in personnel management, he discussed patronage, hiring procedures, union relations, collective bargaining and union negotiations, merit-based hiring, and pension issues. These issues were explored in depth. Stroh retired in December 2000.
