Abstract

Biographical Information Overview of Interview: Brenda Smith was born on August 31, 1948 in Tuscola, Illinois, and grew up on a farm in rural Massac County near Belknap, Illinois. She attended school in nearby Anna, Illinois. She started college at Eastern Illinois University in 1966, where she soon met Jim Edgar, who also attended Eastern. They began dating, and by April 1967, they were married. Brenda also found herself helping with Jim's campaign for student body president. She dropped out of school after their son Brad was born, and by the fall of 1968 they were living in Springfield, where Jim was an intern with the Illinois state legislature.

In 1974, Jim ran for the Illinois state legislature and lost, but he was more successful in 1976. After two years in the legislature, Governor Jim Thompson asked Edgar to serve as his legislative liaison. In early 1981, Thompson again turned to Edgar, this time selecting him as the Secretary of State, a position in which he served for ten years. During this time, Brenda raised their two children, Brad and Elizabeth, in a modest Springfield neighborhood, even as she learned by experience the many roles and responsibilities of a politician's wife. In 1990, when Jim ran for governor, she became one of his most important assets, often hitting the campaign trail on her own. After a grueling race, Edgar won by the narrowest of margins. Brenda next mastered the role of First Lady of Illinois, taking on adoption and children and women's issues as her special passion. She was most proud of her P.J. Huggabee teddy bear program, where children passing through Illinois's foster care program were given teddy bears to help comfort them. When Governor Edgar stepped down in 1999, Brenda gratefully returned to the private life she had always preferred.
