Abstract

Biographical Information Overview of Interview: Janis (Jan) Droegkamp was born in March, 1946 in Milwaukee, Wisconsin. After graduating from high school in 1964 she attended Carroll College in Waukesha, Wisconsin, and after teaching and earning her MA in school counseling from Marquette University. Jan joined the Peace Corps in 1972. She did her training and had her first posting in Jamaica until 1974, then was transferred to Lesotho, a tiny country that was completely surrounded by South Africa. She was there until 1977, during the height of the apartheid era in South Africa.

Droegkamp returned to the United States in 1977 to obtain her EdD at the University of Massachusetts, majoring in international education. For the next few years she did consulting work for the Peace Corps and other international agencies around the world, most notably in Kenya, Thailand and Zimbabwe. While working in Fiji, Jan fulfilled a long-time goal of starting a family. A local Fijian man agreed to father her child, and Jan returned to the United States and gave birth to her son John in 1985. She also started to look for more stable, long-term employment, and was hired by Sangamon State University in Springfield, Illinois. She headed the Credit for Prior Learning Program and also taught at the University. Because of her involvement in Single Mothers by Choice, Jan appeared on the Oprah Winfrey Show in 1991. She continued to work at Sangamon State (later changing its name to the University of Illinois in Springfield), until 2006, occasionally doing overseas sabbaticals researching women's issues. After retiring from her full-time as a full professor emeritus, Droegkamp returned to the Peace Corps, accepting management positions in Albania and Uganda. She retired in 2012 and returned to Springfield where she does a variety of volunteer work.
