Abstract

Biographical Information Overview of Interview: Arnold Kanter was born on December 9th, 1945 in Chicago, Illinois. His father's family emigrated from what is present day Belarus to the U.S. in the late 19th century, and his mother's family emigrated from Poland to Chicago in 1920. Arnie grew up on the west side of Chicago, in the city's 24th ward, before moving to Peterson Park on the city's northwest side in the late 1950s. After attending college at the University of Illinois-Navy Pier and Roosevelt University, he entered Chicago-Kent College of Law in 1968. Nineteen seventy was an especially important year in Arnie's life; he married Yvette Morris and interned in the U.S. Attorney's office. Following his graduation from law school in 1971, Arnie joined the office of the U.S. Attorney for the Northern District of Illinois, a job that brought him into contact with future political luminaries like Jim Thompson, Samuel K. Skinner, and William Bauer.

Arnie left the U.S. Attorney's office in 1977, working for a series of private firms and occasionally advising his friend, 6th Ward alderman Eugene Sawyer; most notably during the chaotic period following the death of Mayor Harold Washington in 1987, when the city council elected Sawyer as Washington's replacement. Through his association with Sawyer, Arnie met many influential people in Chicago's black community, and later drew on this network when he and Erhard Chorle organized Jim Edgar's 1990 campaign efforts in Chicago. Arnie was named counsel for Edgar's transition team after the successful campaign and was named chief counsel for his administration. He served until December 1, 1992, when he resigned his position.
