Abstract

Biographical Information Overview of Interview: Beverly (Scotty) Bruce was born on March 2nd, 1928 and raised in Macomb, Illinois. He attended the lab school associated with Western Illinois State Teachers College (later know as Western Illinois University), and during WW II participated in the Boy Scouts and Civil Air Patrol. Following high school, he attended Western Illinois, graduating with a teaching degree in 1951. He was drafted into the Marine Corps in August of 1951, and following basic training, received intelligence training at Ft. Riley, Kansas. He returned to San Diego for more training, then was deployed to Korea, and assigned to the 1st Marine Division's Reconnaissance Company.

The Recon Company's mission was to conduct reconnaissance patrols between friendly and enemy lines, usually at night, and at the squad level. Bruce describes a typical patrol in detail, and recalls several specific incidents and patrols. He reflected on the difference between Chinese and North Korean enemy troops, and about the rigors of patrolling in the dead of winter.

Bruce rotated back to the states in May of 1953, and found employment almost immediately with the Niantic, Illinois school district, making teaching his life long career. In 1956 he married Edna Mae Riley, and in 1999 the couple returned to South Korea, official guests of the Korean government. Edna Mae and Scotty related their experiences of that trip, and Scotty reflected on his service with the Marines. Scotty passed away on October 12, 2015.
