Abstract

Biographical Information Overview of Interview: Robert Lee Hamm was born in Elkhart, Indiana on July 17, 1923. To avoid entrance in the Army, Hamm enlisted in the United States Naval Reserves. He received boot camp training in Great Lakes, Illinois. After being transferred to Norfolk, Virginia, Hamm became a plank owner of the U.S.S. Franklin. Hamm traveled from Trinidad, again to Norfolk, to the Panama Canal, and eventually to San Diego. In 1942, Hamm eventually headed to Pearl Harbor, where planes and pilots were loaded on the U.S.S. Franklin

He remained in Pearl Harbor for several weeks for gunnery practice. Hamm was involved in the battles of Saipan, Tinian, Guam, and Iwo Jima. He next sailed to the Marianas, the Philippine Sea, and the Palau Islands. In the Battle of the Philippine Sea, Hamm's hangar deck was hit by a kamikaze plane. Due to the damage, Hamm returned to Pearl Harbor for repairs, and then eventually sailed to Puget Sound, Washington. After the ship was finished, Hamm sailed to San Francisco and San Diego, acquiring a new air crew and new missiles. In 1945, Hamm's carrier plane bombed the mainland of Japan. Shortly after, Hamm's U.S.S. Franklin was bombed twice by a Japanese bomber, causing hundreds of fatalities.

Hamm returned to New York, while the war ended in Europe and Japan. Next, Hamm boarded the U.S.S. Lake Champlain and sailed to South Hampton, England to help return troops from Europe. After acquiring appendicitis, Hamm was discharged in Chicago. Hamm moved to Urbana, Illinois and eventually married and had three sons.
