Abstract

Biographical Information Overview of Interview: James H. Fisher was born on October 20, 1924 in Coloma, Michigan. He enlisted in the Navy on June 1, 1942. After receiving boot camp training at Great Lakes, Illinois, Fisher transferred to Iowa State for electrician training. He also trained at a gyrocompass school in San Francisco, California. He became a plank owner on the Landing Ship, Tank (LST) 475 in Vancouver, Washington. He operated the ship from March 1943 to September 1945.

After anti-aircraft armaments were installed on the ship, Fisher traveled from San Francisco, California, to Pearl Harbor; Samoa; New Hebrides; Brisbane, Australia, and New Guinea. Throughout his travels, Fisher was responsible for releasing the stern anchor when docking. Before landing in New Guinea, Fisher's ship was attacked by Japanese planes. He also invaded the New Breton islands, where his ship was trapped on the beach under fire.

Next, Fisher was supposed to land in Hollandia, New Guinea, expecting to face Japanese opposition; however, Japanese soldiers had retreated. Fisher was next involved in the Lingayen Gulf invasion and then the Manila Bay invasion. After returning to New Guinea to load army supplies, Fisher last anchored in Leyte Gulf before returning home.
